# INDEMNITY AND DISCLAIMER

To Variety Queensland – A Member of the Variety Clubs of Australia  
 Queensland Reg Charity No 1255

- 1 **Definitions** In this agreement: **'The 4WD'** means the event The 4WD, **'4WD Director'** means the person nominated by Variety to be in charge of the 4WD. **'4WD Rules'** means the rules set out in the document produced by Variety entitled '4WD Rules'. **'Claim or demand'** means any claim, demand, action, proceeding, judgment, order, award, damage or costs of any nature. **'Participant'** includes the legal or personal representatives of the Participant. **'Entrant's Support Crew'** means and includes (but is not limited to) each person traveling with an entrant in his/her vehicle and each person assisting the Participant in any way including (but not limited to) a mechanic, a member of a mobile workshop team or supply team or any person acting in that capacity and their legal or personal representatives. **'Landowner'** means and includes the owner, lessee or occupier of any land and any employee, agent or independent contractor of such person. **'Variety'** means and includes Variety Queensland Inc and each of its officers, members, employees, agents and independent contractors and any volunteer assisting it in connection with the 4WD.
2. The 4WD is potentially hazardous to those taking part and the Participant does so at his/her own risk. The Participant acknowledges that, although Variety will take all care in connection with the 4WD and the carrying out of the 4WD, Variety accepts no responsibility for any Claim or Demand by any person or participant.
3. The Participant will comply with all laws and legal requirements and with all directions of the 4WD Director regarding safety including, but not limited to, requiring Participants to undergo alcohol breath tests. The 4WD Director may require any Participant to cease participation in the 4WD if the Participant has a blood alcohol in excess of that permitted by law. The 4WD Director may also require any Participant to cease participation in the 4WD if it is, in his or her opinion, in the interests of safety. The event is NOT A RACE. Any vehicles found to be breaking road laws, 4WD Rules or driving in an unsafe or inconsiderate manner (including hooning, burnouts, drifting, speeding, etc) will be immediately excluded from the 4WD. At this time the driver and any passengers forfeit any money paid to Variety and will not be entitled to any recompense.
4. All vehicles must be registered and roadworthy,
5. All drivers must at all times hold a current Driver's Licence and produce same when requested by the 4WD Director.
6. This Agreement will not be affected or altered except by Variety. The Participant acknowledges that he/she has not relied on any representations made by or on behalf of Variety.
7. The Participant indemnifies and holds harmless and will keep indemnified and hold harmless:
  - A) Variety, from all Claims or Demands, whether known or unknown, by any person against Variety arising from or related to, either directly or indirectly, the 4WD or the conduct of the 4WD; and
  - B) Each Landowner from all Claims or Demands, whether known or unknown, by any person against the Landowner arising from or related to, either directly or indirectly, the 4WD or the conduct of the 4WD.
8. The Participant releases and forever discharges Variety and each Landowner from all Claims or Demands, whether known or unknown, arising out of or relating to the 4WD or the conduct of the 4WD.
9. This agreement is governed by and construed in accordance with the law of the State of incorporation of Variety.
10. The Participant must comply with 4WD Rules. The 4WD Director may require the Participant to cease participation in the 4WD if the Participant fails to comply with any of the 4WD Rules.
11. Further conditions of entry may be prepared by the 4WD Director and will be printed in a regular Newsletter issued from the Motoring Events office and the Participant must comply with these further conditions.
12. Emergency/temporary vehicle repairs carried out by mobile workshop crews are carried out to the best of their ability under the conditions. Should you require the assistance of mobile workshop crews for emergency/temporary repairs to your vehicle during the event, such repairs are considered temporary repairs only. Variety or the mobile workshop crew involved take no responsibility for the emergency/temporary repair and it is the responsibility of the participant to have emergency/temporary repairs checked by a qualified mechanic at either the next town or at the first reasonable opportunity.
13. The Decision of the 4WD Director regarding any matter is final.
14. I hereby consent to any videotape, photographs, and/or motion picture film in it desires, including television. Furthermore, I hereby consent that such photographs, films and recordings and the plates and/or tapes from which they are made, shall be the property of Variety, its assigns or successors, and it shall have the right to sell, duplicate, reproduce and make other uses of such photographs, films, recordings, plates, and tapes as they desire, free and clear of any claim on my part.

NOTE: This Indemnity and Disclaimer must be signed by all persons taking part in the Event in any way including but not limited to, the Participant, crew members, officials, pilots, members of the media, members of mobile workshop teams, mechanics and truck operators.
